Our new Kitchen Manager Todd and our kitchen team have put together a delicious restaurant style menu and the new dishes have been receiving rave reviews.



Support at Home - What it means for current HCP participants

On 1 November 2025, the Home Care Package program (HCP) was replaced by Support at Home. If you were already receiving care under HCP, here's what the changes mean for you.

Your Care Will Continue

The most important thing to know is that your care and services will not stop. You will automatically move across to the new program, and you'll continue to receive the support you rely on. And you'll still be able to update your care plan if your needs change.



Grandfathering Protections

For participants who already had (or were approved for) a HCP before 12 September 2024.

The Government has put in place grandfathering arrangements to protect existing HCP participants. This means:

- Your current funding will continue under Support at Home.
- You won't pay more in contributions than under your HCP.
- Existing hardship arrangements are carried into Support at Home.
- Any unspent funds you've built up in your HCP account will transfer across to your Support at Home budget.
- You'll remain "grandfathered" for as long as you stay with the program so there's no disadvantage for participants who've been receiving support before the transition.

For new HCP participants or those who received their HCP after 12 September 2024. There will be client contributions payable on some services. The amount will depend on the type of service and your financial situation.

How much will I pay?

The contribution amount will be between 5 and 80% of the hourly rate, and is means tested.

- Clinical care fully funded, no out-of-pocket cost
- Independence services small co-payment may apply
- Everyday living services (like meals and cleaning) higher contribution rate.

We're Here to Help

We know change can feel uncertain. Our priority is to keep you informed and make this transition as stress-free as possible.

We are aware of some misinformation about Support at Home in the community. We would encourage any participants with concerns to contact their Care Partner or our General Manager for clarification.


